Fully describe the business's activities?

The school offers preschool, aftercare and babycare based on the Montessori education philosophy. The curriculum includes language literacy, mathematics, practical life, cultural and sensorial subject matter. Also offered are CAPS, Grade R and s tutor centre. In 2026 the owner decided to concentrate on preschool activities and reduced the intake. The figures presented are a forecast for F2027 based on enrolments achieved in F2025, before the owner decided to downsize the school.

How does the business operate on a daily basis?

Children are dropped at the school at the start of the day. They participate in the appropriate curriculum and are collected on completion of the days activities. The school provides breakfast and lunch for the children. Snacks and other consumables such as diapers are provided by the parents.

What Advertising/Marketing is carried out?

Website and front facing signage on a high traffic location in a developed business corridor

What competition exists?

There are other preschools but no other Montessori schools or English medium schools are in the area.

How could the profitability of the business be improved?

There is an unutilised area that could be converted to double the capacity of the school and increase the footprint and increase the preschool or accommodate a primary school.
A tutor centre would expand the school offering while significantly boosting revenue and profitability.
