This well-established nursery school provides care, stimulation, and early childhood education for children aged 3 months to 5 years. The school currently has 74 enrolled children and offers a bilingual learning environment in both Afrikaans and English. It follows the ELDA curriculum and is a proud member of the SA Childcare Association, ensuring adherence to high standards in early childhood development. Children receive nutritious meals daily, including breakfast, morning snacks, lunch, and afternoon snacks. The school operates from four well-equipped classrooms, each catering to a specific age group: a baby class for infants aged 3 to 18 months, a class for toddlers aged 18 to $24\frac{1}{2}$ months, another for children aged $24\frac{1}{2}$ to $3\frac{1}{2}$ years, and a final class for children aged $3\frac{1}{2}$ to 5 years. These classrooms provide a safe and nurturing space for age-appropriate learning and play.

The school operates Monday to Friday from 06:30 to 17:30. The owner personally opens the school each morning and oversees the daily operations, ensuring smooth running and high standards of care.
