The business operates as a pool cleaning and repairs business in the heart of the Cape Winelands in the Western Cape.

Besides pool cleaning services they also offer pool repairs and fibreglassing as well as the repair of leaks and pump repairs.

### How long has the business been established?

The business has been operating for 19 years having been founded by the owner in 2006.

#### How does the business operate on a daily basis?

The owner manages the business on a daily basis. Staff are dispatched on their various routes daily. There are about 180 pools being surfaced.
