Weaknesses?

There are a number of opposition companies within a 3 km radius. Load shedding has a small negative effect in that lifts cannot be utilised in this time. Shop needs a refresh and an additional R400k would need to be spend to complete this

Opportunities?

Surrounding industrial area has numerous businesses with small to large fleets of vehicles. There are no franchised or recognised service centers in the area. There is currently have a number of small businesses from that area but cold calling and offering discounted rates to these companies will definitely increase the sales.

Follow the same approach and offer discounts to the many staff of the corporate office blocks in the area

Business has been approached by competition to assist with overflow work, but have to date, not engaged with them to finalise an agreement.
