This business is part of a strong and well known franchise group that provides affordable services and repairs to all types of cars and bakkies.

How does the business operate on a daily basis?

Clients will come/phone in and receive a quote, the client will instruct which services should be performed and drop off the car, and payment will be made when the car is picked up.

What Advertising/Marketing is carried out?

Advertising is done by the franchisor and each franchisee pays 2.5% of turnover towards this on a monthly basis. Each franchisee is strongly advised to also advertise in their own area via pamphlets, etc.

There is a very strong online strategy driven by the franchisor. The franchisor often runs billboard campaigns as well as in store campaigns such as Women's day, youth month, Easter specials, etc. and these are marketed and supported by online and social media campaigns.

The franchisee also markets by handing out flyers at traffic intersections, local newspaper ads etc.

What competition exists?

There is competition in the area but the business is not affected by it due to their good prices.

How could the profitability of the business be improved?

The parts ratio i.e. cost of sales (parts) as a percentage of turn over needs to be looked at. The average for the group is 30% and according to the financials, this business is at 42%.

Due to problems experienced by changing accountants this issue has not been investigated and there should be a substantial benefit once this cost have been corrected and brought in line.
