The turnover amounts to R695k pa, broken-down into : R523k from scheduled garden services & R122k from ad hoc clean-ups/tree felling & R50k from dealer commission on selling equipment, while the Net Profit/ Owners Discretionary Income (including his benefits) amounts to R366k pa (with every expense covered); while two other side-line businesses (under opportunities above) could be linked hereto.
