Inspection and test of pressurized equipment, air receivers and boilers.

How does the business operate on a daily basis?

With an enquiry, a quote is issued and a accepted inspection is scheduled.

Once onsite, commence with the set-up of the inspection area and isolate the equipment ready for inspection.

Inspection equipment is on a bakkie and the assistant and owner carry out the inspection.

Equipment is re-instated once test is successfully completed and recommissioned.

What Advertising/Marketing is carried out?
