The owner initiated the setup of the business 5 years ago.

The business activities can be summarized as planting, picking and supplying supermarkets and private clients with strawberries.

The delivery of the strawberries to the supermarkets and private clients is done by the owner per orders received.

## Give a breakdown of staff/ functions/ length of service?

There be no need for highly skilled / trained labour force.

The business merely requires the workers to plant, maintain and pick strawberries

#### How involved is the Owner in running the business?

The owner is involved in the daily running of the business.

Main activities of the owner is to pick up of the staff that will be working for the day, general oversight of their work and arranging for the delivery of the produce to the retailers / supermarkets.

#### When does the current lease end?

The current lease ends in 2029.

#### What are the trading hours?
