The Owner handles all of the general management functions, supported by a manager and the cleaning team. A manager will not be required if it were a husband and wife team handling the business. There are two business streams, namely the rental bookings which earn a commission with very low related costs, and also the servicing of the holiday accommodation with the related expenses.

What Advertising/Marketing is carried out?

The Website and on-line facilities are an extremely important form of advertising and marketing to attract visitors to the rental homes

What competition exists?

There are other competitors in this space however this business is known as the "Go To" business for those wishing to rent out their homes, as they offer outstanding reliability and service levels in this very lucrative area..

How could the profitability of the business be improved?

The Owner has been working with a manager and oversees a lot of the check-ins herself.

If it were a husband and wife team it would be a lot easier and there would be financial savings too

How involved is the Owner in running the business?

Full time on a daily basis, 7 days per week if and when required.
