Products are sprayed in two spraybooths with an overhead conveyor system travelling through a drying tunnel. Once completed, products are then packaged and sent out for delivery throughout SA as well as Africa. The working hours are Monday to Friday.

The current customers of the business do all of their own marketing and advertising on their own social networks.

Similar operations located in the country supply exclusive Blue Chip corporates.
