Online Life Coaching & Development, with Corporate Coach Training products set-up but not actively sold. The business has an international reach & minimal interface with clients. The owner operates the business herself, having created an enticing & interactive website, that allows clients to move easily along the sales path & value chain, selecting the accredited course appropriate to themselves, with perhaps some emails & a smattering of WApp conversations.

The business holds 2 licence's, with all courses are certified with COMENSA & ICR, (at a total cost R10k pa including Learndash).

How does the business operate on a daily basis?

Owner checks on the website & emails, answering any queries, thereby ensuring a steady uptake of courses by new & existing clients.

She will also occasionally review courses, accreditations, competition, to keep her business relevant..

The website & Facebook are the main drivers, with google-ads at some R7-10k pm & referrals, ensuring a steady R1m gross income pa.

Management accounts are produced monthly & mirror the Bank Account.
